## Schedule 1—Amendments

### *National Disability Insurance Scheme (Specialist Disability Accommodation) Rules 2020*

#### **1 Section 5 (definition of *in-kind support*)**

Repeal the definition, substitute:

*in-kind support*: see section 6A.

#### **2 Section 5**

Insert:

*relevant jurisdiction*, in relation to a participant and a support, means the State or Territory in which the participant is provided with the support.

#### **3 After section 6**

Insert:

#### **6A Meaning of *in-kind support***

A support is an *in-kind support* if:

- (a) the support is available to be provided to the participant by a provider who is:
  - (i) the relevant jurisdiction; or
  - (ii) the Commonwealth; or
  - (iii) a provider under a service delivery mechanism operated by the relevant jurisdiction or the Commonwealth; or
  - (iv) a person engaged or funded by the relevant jurisdiction or the Commonwealth; and
- (b) the support is made available to the Agency on an in-kind basis as part of the contribution to the National Disability Insurance Scheme made by:
  - (i) the relevant jurisdiction; or
  - (ii) the Commonwealth;whether or not the participant has previously been provided with the support.
