1. Do you have any comments on the proposed structure of the Strategy?	It appears unusual that the principles and particularly evidence look as if they feed into indicators. We are wondering if the principles and Evidence should feed into the Vision instead. In this way the Evidence (e.g., research base) informs the principles and then comparatively informs the vision and each component of the strategy.
2. What vision should our nation have for Australia's youngest children?	* All children are supported to reach their full potential * Families are supported to care and educate their children * All aspects of children's health, wellbeing and learning needs are met * All children have equity of access to early childhood education and care * Children and families have access to integrated support services that fully support their needs * Access to quality education is a right for all and is accessible regardless of income or location * Children and families are supported in ways that demonstrate respect and honouring of diversity and inclusion * First Nations children and families are prioritised and respected as the first peoples of this country. * First Nations children and families have access to an education and care system that is culturally responsive, provides education in first languages where relevant and supports in place responsive solutions to current barriers to quality education and care * First Nations children and families are empowered to guide all decision making that affects education and care * Children have access to a highly trained, qualified and competent ECEC workforce that is well respected and supported. * The Un Convention of the rights of the child is upheld and has to be considered in all policy decisions impacting the lives of children and their families * Children's voices are included in decisions that affect them and their lives * All children have access to education and care that is responsive to their learning style, development needs and personal dispositions
