1.1 What would a partnership between CSOs and the government that achieves outcomes for Australians being supported by the community sector look like?

more robust and stronger enforcement teams. we have come across many Participants who are scared of the current providers they are with.

i believe a community visitor for participants would be hugely beneficial.

1.2 How can CSOs and government streamline the sharing of information, particularly through utilising technology to effectively engage, distribute, share, influence and inform in a timely and efficient manner?

the current system is lacking, and i don't know what the new system will look like going forward. but more information needs to be shared with the NDIS sector to NDIA itself. this information isn't getting to NDIA, which is leaving Participants left behind, not feeling cared for and feeling like they are just money to providers.

1.3 How can government ensure the community sector, including service users, and those not able to access services, have an opportunity to contribute to program design without imposing significant burdens?

as a registered provider we have to provide surveys to our participants. this would be good to get feed back from the participants.

in my previous answer, I did state about a community visitor going and seeing participants without their support worker so you can get a good understanding of what the providers are doing for their participants.

2.1 What would adequate and flexible funding look like?

to be honest there should be a medium amount of flexible funding, the funding that is currently being used as "Flexible Funding" is not used correctly.

funding should be stated toward peoples plans and allow choice and control through certain areas.

we have seen people get their holidays completely paid for including flights, accommodation and food. one person i know even went to Bali which was not good use of funds.

we have seen people get their house renovated, beds purchased and this was not part of their goals.

2.2 What administrative and overhead costs are not being considered in current grant funding?

we drive around in rural areas sometimes we are driving close to 2 hours without any pay or paying our staff the extra which is a massive lose for our business.

2.3 How are rising operational costs impacting the delivery of community services?

the cost of renting an office, fuel prices, and the general cost of supplies to keep a business going has gotten to the point of having to work from someone's house just to save money.

2.4 What have been your experiences with and reflections on the supplementation and change to indexation?

poor at best, we currently are taking twice as long to grow and take on more participants due to the indexation, the current hourly price for work, and our ability to grow is slowed extremely.

2.5 How can CSOs and the department work together to determine where funds are needed most to ensure equitable and responsive distribution of funds?

i believe only NDIS-registered providers (within the NDIS Scheme) should get the funding. the outgoing cost of audits has risen to extremes. our audits cost us close to 10,000 AUD every year and a half. plus the constant update and maintenance of policies and procedures for our staff.

constant training for our staff is a must top keep everyone up to date with the current practices through WHO and other departments.

2.6 How can government streamline reporting requirements, including across multiple grants, to reduce administrative burden on CSOs?

only NDIS registered business should be getting the grants (within the NDIS Scheme)

3.1 What length grants are CSOs seeking to provide certainty and stability for ongoing service delivery?

consistently

so having the funding allocated to a yearly amount and doing the payments 4 times a year would be beneficial.

3.2 What timeframes should the government aim for, at a minimum, to provide final outcomes on grant variations/extensions before the current grant ceases?

within 30 days.

we have applied for a grant and we didn't hear anything back 90 days later

3.3 What funding flexibility do CSOs require to enable service delivery and innovation?

somewhat flexible.

there should be a stated goal in mind for a grant such as, updated equipment for staff training or vehicle that are required for wheel chair access ECT

if the funding is stated then that's what the funding should be spent on.
