### **Privacy Collection Notice**



This document tells you

- The rules we have to follow when we collect your information
- What we will do with your information.

In May 2024 the Australian Government said they wanted to set up a committee.

The committee is called **NDIS Reform Advisory Committee**.

We call it the NDIS RAC for short.



We are looking for people to join the NDIS RAC.

They might be

- People with disability
- People with experience with disability.



Anyone who wants to join the NDIS RAC needs to put in an **Expression of Interest**.

We call it an **EOI** for short.



An EOI is an application form that says you want to join something.



When you put in an EOI you will give us personal information like

- Your name
- Your email address.



We will not ask for

• Your phone number

• Your address.



The information you give will help us choose who will be a **committee member**.

A committee member is someone on the NDIS RAC.



We have rules to keep your information safe.

Only people who need to see your application will look at it.

## What is personal information



#### Personal information is information like

• Your name



• Your phone number



• Your address



It is information so we can tell people apart.



#### We will not ask for you to share

• Your phone number



• Your address

With us.

#### What is sensitive information



Sensitive information is information like

- What you think
- Different groups you join.



They could be things like

• What country you are from



- What you think about politics
- What religion you practice



- Groups you join
- Who you have relationships with.

### What information do we collect



If you fill out an EOI we will ask for your

- Personal information
- Sensitive information.



We will ask for your

- Name
- Email address



Gender

People say what gender they are.

They might be

- Male
  - Female
  - A different gender
  - No gender.





- Your age
- Groups you are part of



• Where you live



• Your disability



• Your experience with disability.



We might also collect information about what you think about



• Your experiences



• Important issues for the disability community



 How you listen to and speak up for people with disability



• Working with the government



 Your experience in helping to make or change programs to make life better for Australians



• Working with **diverse** disability communities.

Diverse means lots of different communities like



• First Nations communities



• People who speak other languages



• LGBTIQA+SB



- People who live in places that are
  - Regional
  - o **Rural**
  - Remote



• People with complex needs.

#### Why we collect your information



You send us your personal information if you fill out the EOI.



You will **not** be able to join the NDIS RAC if you do **not** 

- Fill out the EOI
- Give your personal information
- Give your sensitive information.



The personal information you give helps us

 Choose who will be best to join the NDIS RAC



 Make sure people with disability join the NDIS RAC



 Include lots of people from different backgrounds.



We keep all information sent to us safe.

## Who we might share your information

#### with



There are some people we might share your personal information with like



• The NDIS Minister

A Minster is a leader in government.



- People who work for the NDIS Minister or the Australian Government
- The NDIS RAC Co Chairs



• State and territory Disability Ministers



 People who work for state and territory Disability Ministers or departments



• When the **law** says that we have to

Like if someone might get hurt.

Laws are rules for how we live.



• Services Australia.

They help us with our website.



Everyone who might see your information has to follow the same rules to keep it safe.

We will **not** share any information with people outside Australia.

#### **Storing your information**





#### There are rules for

- Storing personal information
- Getting rid of personal information when it is not needed any more.



We keep all personal information in

• Service Australias cloud storage

Cloud storage is the way we store information from computers.

It is **not** a real cloud.

It saves the information to a system through the internet.



• Servers in Australia.

Servers are special machines that help hold lots of information.

The information can be accessed through the internet.



We work with Services Australia to keep all the information stored like this safe.

We can use all the information we have stored.



We follow the rules with who we can share the information with.
