What is changing?



We are making the National Disability Insurance Scheme better.

It is called the NDIS for short.



This document is about the NDIS Supports rule.

This rule explains what people can use their NDIS **funding** for.



Funding is money from an **NDIS plan** that pays for the supports a person needs.



An NDIS plan has information about:

- the person and their goals
- what support they need
- what the NDIS will pay for.



We want to make the NDIS Supports rule clearer.



We want to hear from people who use the NDIS Supports rule.

Why do we want to hear from you?



We have been using the NDIS Supports rule since October 2024.

The rule includes lists of supports that people:



• can use their NDIS funding for



• cannot use their NDIS funding for.

They are not Easy Read documents.

In 2025 we will update the NDIS Supports rule.

We want to know:



• how well these lists work for you



• how we can make them easier to use.

What have we heard so far?



We have heard from more than 7,000 people so far.

We heard that the NDIS Supports rule helps:



some people know what supports they can use their NDIS funding for



some NDIS providers know what supports they can deliver.



NDIS providers use the money in a person's NDIS plan to support them.



We also heard that the lists of supports can be confusing.

For example, some people do not know what supports are included in day-to-day living costs.



We heard that people should be able to use their NDIS funding for more common items.

This includes common items that:



 support them the same way as NDIS supports



• cost less.



We heard that people should be able to use their NDIS funding for types of **therapy** that work well for them.



Therapy includes different types of support that can help improve how:

- you communicate
- you think and feel
- your body moves.

For example, **speech therapy**.



Speech therapy can help people improve how they:

- communicate
- swallow safely.



We heard there should be more information about who can provide some supports.



We heard that people who make NDIS plans can think the lists mean different things.

This can be confusing.


